## 1. Subject

Threat to merchant marine, and ships's protection in the Red Sea, the Strait of Bab el Mandab, the Gulf of Aden, and the northwestern Indian Ocean.

# 2. Purpose

To highlight risks and recommendatory measures for San Marino registered ships transiting through sea areas where terrorist, pirate and armed robber attacks are taking place.

## 3. Acronyms

### 5. Current situation

- 1. An area of high maritime threat has been established by the coalition navies. The northern boundary of this area is parallel 17° 30'N in the Red Sea, and the boundary to the southeast is in, the Northwest Indian Ocean, at parallel 10° 00'N and meridian 056° 00'E and a voluntary reporting guidance in the Indian Ocean and Red Sea region has been established.
- 2. In December 2024 several changes have been made to regional voluntary reporting scheme. CMF, MSCIO and UKMT have agreed as follows:
  - a) To implement a single information reporting framework by 31 March 2025. This new framework includes CMF, MSCIO (EUNAVFOR operations ATALANTA and ASPIDES), and the UKMTO. The aspiration is to broaden the framework to include Regional Information Fusion Centres (IFCs), such as IFC (IOR), RMIFC, IFC-Singapore, and RCOC;
  - b) To adopt standardised Reporting Formats enabling mariners to use the same form to whoever they choose to report. Initial reporting to both MSCIO and UKMTO is recommended;
  - c) To suggest maritime shipping considering UKMTO acting as the primary point of contact for emergency response and MSCIO as the secondary point of contact;
  - d) That all reporting centers will use the Voluntary Reporting Area (VRA) as shown on UKHO Chart Q6099<sup>12</sup>;
  - e) To simplify and align the Incident and Report Forms across all regional reporting centres;
  - f) To recommend using, if there are concerns or question, the following contacts:

- 3. On 15 January a significant ceasefire agreement between Israel and Hamas was announced. By 17 January it was confirmed that both parties had signed the agreement in Doha,Qatar.

- 4. Following the ceasefire, the Houthis announced a pause in their campaign against commercial shipping in the Red Sea and the Gulf of Aden for all categories of ships except Israeli-flagged or directly owned by Israeli entities.
- 5. The Joint Maritime Information Centre (JMIC) has issued a warning that the maritime industry should be sceptical of recent Houthi claims, and the threat to shipping associated with Israel remains high.
- 6. Several organizations (e.g. The Lloyd's List and ACLED) provide easy-to-read map, list of attacks, and analysis on their websites<sup>13 14</sup>.
- 7. Master, Ship Security Officers, and Company Security Officers while planning the transit in the area of high maritime threat should consider the recommendations set out in article 6 of the Directive No.06/2024 SEC 3.3 dated 31 October 2024.
